Program for the personnel of armed forces

1. Member of Armed Forces

strict regulation to confirm the status of any requestor as member of the armed forces are required !

- **Proposed course of action**

- establishment of a “Single Point of Cooperation (Communication) - PoC” in both Participating States
 - **Austrian PoC: booking@hbv.gv.at**
- Any communication will be administrated by these PoCs
 - With the initial approach for any stay the requesting PoC confirms the status of the requestor as a member of the Armed Forces

2. Persons eligible

- **Eligible persons of both Participants are**

- personnel of the armed forces and/or
- personnel of the Ministry of Defence,
- including following persons accompanying the a.m. personnel
 - spouses,
 - partners (cohabitans), and
 - children (in age of compulsory school attendance)

3. Individual responsibility

The individual responsibility in the receiving Participant State includes but is not limited to

- Payment for the stay directly to the “hotel” in the local currency (credit cards accepted) not later than by check-out
 - Payments includes all received commodities e.g. accommodation, meals and refreshments
 - How are your procedures regarding payment and cancellation?

- Arrange the travel to and from the receiving Participant State
- Arrange all domestic transportation within the receiving Participant State
- All personnel apply to all customs regulations of the receiving Participant State

4. Information concerning locations

- After confirmation of the eligibility of the requestor and availability of rooms all communication will take place between the POCs
- An “On-Site Service Catalogue” has been made available
- Any answer to a specific inquiry will include the approximately cost of stay

5. Confirmation

Following practical understanding concerning the Vacation Opportunities with regard to the procedures of the Austrian Participant could be confirmed:

- 1) All communication will take place in English
- 2) Following locations of the Austrian Armed Forces are possible for booking
 - 1) REICHENAU, ISELSBERG, FELBERTAL, VIENNA (Breitensee)
- 3) All prices (accommodation and meals) have to be prescribed by Austrian law by 1. January each year (depending on the Austrian price index)
- 4) The procedures of any cancellation will be treated exceptionally
- 5) Booking requests
 - 1) are possible throughout the year, depending on room availability
 - 2) Answers respectively booking confirmation will be returned not later than 5 weeks before arrival
 - 3) Any booking confirmation includes a costs estimate
- 6) Meals:
 - 1) In general half board will be offered (breakfast and dinner) except Vienna (only breakfast)
 - 2) No vegan meals available
 - 3) No consideration of allergenic restrictions
- 7) All locations are non smoking areas
- 8) No transportation within Austria will be provided by the Austrian Armed Forces
- 9) In general no health care services will be provided by the Austrian Armed Forces

1) Especially for any hill walking and/or skiing a travel insurance including helicopter rescue option is recommended!

10) No pets are allowed!
